## Career Summary

George Zeitler has had an active role in the maritime industry for decades. As the Chief of Vessel Inspection Division and School Chief for the US Coast Guard's Cruise Ship Center of Excellence, his leadership, mentorship and decisions were far reaching and served as a positive inspiration for many. As a Principle Surveyor and Lead Instructor for DNV-GL he continued to earn the respect and admiration of leaders at the highest levels of the marine industry.

A graduate of the U.S. Coast Guard Academy where he studied naval architecture and marine engineering, George combines a strong blend of shipboard operational experience, extensive technical knowledge, and an impressive regulatory compliance record. In 2020, he was awarded a Master of Science (with distinction) in Marine Operations Management (Marine Surveying) by Middlesex University in London, UK.

Some of George's most successful work as a project manager involved his role as on-scene coordinator for the salvage of multiple ship groundings in the South Florida region. Demonstrating his technical knowledge and his ability to manage diverse teams, he was successful in overseeing the timely salvaging of 3 cargo ships (197m *Clipper Lasco*, 167m *Federal Pescadores*, 166m *Eastwind*) and the luxury motor yacht *TV*.

At the end of 2014, George left his role as a Principal Surveyor and Customer Service Manager for the international Classification Society DNV GL to help bring the cruise ship *Grand Celebration* into US service with a new cruise line in West Palm Beach, Florida. His efforts were vital to the vessel completing a successful change of Flag, change of Class Society, full USCG plan review and initial inspection within 45 days of taking delivery of the vessel.

In 2015, after the successful startup of the newly formed Bahamas Paradise Cruise Line, George resigned in order to fully utilize the over twenty-seven years of experience and knowledge he had obtained. In addition to focusing full-time with his own company: Zeitler Marine Service (ZMS) which provides a wide range of support to yacht and small craft owners, he co-founded Reliable Maritime Solutions which provides surveying and consulting support that has included compliance surveys, risk assessments and environmental compliance audits on ships ranging from the newest cruise ships to Ro-Pax ferries and military cargo vessels. They have conducted numerous pre-purchase and valuation surveys on passenger and cargo vessels, have assisted with a variety of issues with Maritime Authorities, and provided consulting services to operations of all sizes. As third-party auditor, Charlie provided in-depth and effective environmental compliance audits world-wide for a high-profile environmental crimes case. These audits identify vulnerabilities onboard the vessels and gaps in company's policies and procedures. These efforts were critical reducing the risk of potential violations.
