Scott Margraves started his second career as a full-time expert witness in 2020, backed with over thirty-three years commercial property & casualty insurance experience. Mr. Margraves has been designated as an expert witness in 22 case assignments: 19 State cases and 3 Federal cases. Case assignments are divided between 12 for Defense and 10 for Plaintiff, including Arkansas, Colorado, Illinois, Louisiana, New Mexico and Texas. He is an insurance industry expert that brings extensive experience in all aspects of property & casualty insurance interpretation, policy forms, applications, claims, safety programs, and contract integration. Expertise includes Bad Faith, Agency E&O, Standard of Care, Marine, Environmental, Surety & Bonds, CYBER, and Certificates of Insurance.
