

**James Patrick Murphy, MD: summary of federal cases providing live expert witness testimony.**

1. UNITED STATES OF AMERICA, Plaintiff, v. KRISHAN KUMAR AGGARWAL and CHERIAN JOHN, Defendants. United States District Court for the Northern District of West Virginia. Case No. 5:18-cr-16-FPS. May 1, 2018. The jury returned not guilty verdicts, June 14, 2019.

2. UNITED STATES DISTRICT COURT SOUTHERN DISTRICT OF WEST VIRGINIA AT CHARLESTON, UNITED STATES v. Nasher-Alneam. Case number 2:18-cr-151. May 22, 2019. Jury deadlocked; mistrial declared and case was resolved with plea agreement before retrial.

3. UNITED STATES OF AMERICA, Plaintiff, v. BARBARA TEMECK, Defendant. United States District Court, S.D. Ohio, Western Division. Case No. 1:17-cr-00050. November 14, 2017 - Guilty verdict was vacated and charges were dropped.

4. UNITED STATES OF AMERICA, Plaintiff, v. ALAN GODOFSKY, Defendant. United States District Court, Kentucky Eastern District Court. Case No. 5:16-cr-00059. Case Filed: July 7, 2016. Guilty verdict.

5. UNITED STATES OF AMERICA, Plaintiff, v. GEORGE KUDMANI, Defendant. United States District Court, Western District of Kentucky, Louisville Division. Case No. 3:13CR-00173-JHM. March 22, 2017 (retrial of deadlocked jury case, see below). Guilty verdict.

6. UNITED STATES OF AMERICA, Plaintiff, v. GEORGE KUDMANI, Defendant. United States District Court, W.D. Kentucky, Louisville Division. 3:13-cv-01063 Indictment: December 4, 2013. Deadlocked jury, mistrial declared (see retrial above).

7. UNITED STATES DISTRICT COURT EASTERN DISTRICT OF KENTUCKY SOUTHERN DIVISION PIKEVILLE. UNITED STATES OF AMERICA, Plaintiff, v. EMMANUEL GALANG ACOSTA, Defendant. Criminal No. 12-11-ART (1), (2), (4). November 8, 2013. Testified at deposition. Case resolved with plea agreement before trial.
